The complaint for foreclosure is the document that outlines the lender's claims underlying the lawsuit. For example, the complaint will describe the mortgage (or deed of trust), the promissory note, the property to be foreclosed, the default, the amount due, as well as list the defendants and describe their interest in the property. This must occur within 35 days from receipt of the summons and foreclosure complaint.
